21 Notice is hereby given to Respondent COUNTY OF SONOMA under Public Res. Code  
22 §21176.5 of commencement or anticipated commencement of this lawsuit challenging its actions  
23 made on or about December 14, 2010, certifying an Environmental Impact Report ("EIR"),  
24 adopting a Mitigation Monitoring and Reporting Program and Statement of Overriding  
25 Considerations, and approving (1) a Zone Change to add a MR (Mineral Resources) overlay zone  
26 to an approximately 198 acre site located at 7601 and 7175 Roblar Road, County of Sonoma,  
27 Assessor's Parcel Numbers 027-080-009 and -010, (2) a Use Permit with a term of 20 years to  
28 allow mining and asphalt recycling with an annual production limit not to exceed 570,000 cubic

1 yards per year, and (3) a Reclamation Plan for the approximately 70 acre site, for the "Roblar  
2 Road Quarry Project" proposed by Real Party in Interest JOHN E. BARELLA AND ANDREA  
3 M. BARELLA TRUST.


